

# Apply to Caswell County NC Pre-K

Dear Prospective 2018-2019 Preschool Parents:



Caswell County Schools is accepting applications for the North Carolina Pre-Kindergarten (NC Pre-K) Programs. Caswell County NC Pre-K programs are publicly funded. They prepare children for school by using a curriculum approach that enhances children's physical, social, emotional and intellectual development.

To be considered for the 2018-19 Caswell County Pre-K programs, **your child must be 4-years old on or before August 31, 2018**. Applications received will be considered for the NC Pre-K classrooms located at North Elementary School, South Elementary School, Oakwood Elementary School, and Caswell Community Head Start.

Pre-K placements for Caswell County School sites are made based on program specific factors (educational need), not on a first-come, first-served basis. The applicant pool is rank-ordered and the child who will benefit most from pre-kindergarten services is offered placement first. When classrooms reach capacity, a rank-order wait list is maintained to fill any vacancy. You will be notified of your child's pre-kindergarten placement status by mid-June.

**Only complete applications** will be processed. Once it is confirmed that your application is complete, we will call you to schedule a developmental screening appointment for your child. The screening appointment lasts about 1 hour. The dates and locations for the screenings are as follows:

- **South Elementary-** Wednesday, April 25<sup>th</sup>
- **Stoney Creek Elementary-** Friday, April 27<sup>th</sup>
- **North Elementary-** Tuesday, May 1<sup>st</sup>
- **Oakwood Elementary-** Thursday, May 3<sup>rd</sup>



**PLEASE NOTE: THE NC PRE-K APPLICATION FORM MUST BE COMPLETED AND SIGNED IN ORDER TO APPLY**

The following **REQUIRED** information is needed before your child can be screened for the preschool program:

- **NC Pre-K Application Completed.**
- **Copy of your child's birth certificate** (official copy needed/ mother's copy will not be accepted)
- **Proof of residence\*** (current light/water bill or lease agreement or affidavit of residence form)
- **Proof of all income\*\***(three consecutive check stubs for each employed parent/guardian, child support, retirement, worker's compensation, statement from supervisor, 2017 IRS 1040, unemployment, social security, W2, public assistance). If "0" income is reported on your application, complete the Pre-K Statement of Zero Income on the back of your NC Pre-K application.
- **Immunization Record**
- **Caswell County Schools Data sheet**
- **Transportation form**
- **Copy of Driver's License or NC Picture ID Card**
- **Military Member's Leave & Earning Statement** (for child of eligible military family)

\*Reside with another family? Bring a notarized Affidavit of Residence statement (see attached) from the homeowners and a copy of their current light/water bill.
