## Breakfast and Lunch **FREE** for All **Elementary** Students

**Community Eligibility Provision (CEP) provides meals free to students.**

Beginning in the 2014-2015 school year, all elementary students in Caswell County Schools were able to eat breakfast and lunch free each school day; **this will continue for the 2018 - 2019 school year.**

The Community Eligibility Provision allows schools to offer both breakfast and lunch at no cost to all students in identified school locations.

### Elementary School

**Parent Question:** Should I fill out a meal application for my elementary child?

**Answer: - NO**

In 2018 - 2019, if your child will be attending one of the following schools:

North Elementary School	South Elementary School
Oakwood Elementary School	Stoney Creek Elementary School

**You will not need to complete a meal application for your child.**

### Middle School & High School

**Parent Question:** Should I fill out a meal application for my middle or high school child if I want to apply for Free or Reduced meal benefits for the 2018 - 2019 school year?

**Answer: - YES**

If you have other children who will be attending Dillard Middle School or Bartlett Yancey High School, and you would like to apply for Free or Reduced Meals for your child, an application for the 2018 - 2019 school year will still be needed.

**Your child's 2017 - 2018 eligibility for free and reduced meals will carry over into the 2018 - 2019 school year for up to 30-operating days or until a new eligibility determination is made, whichever comes first.**

**All students going from a CEP school to a Non-CEP school will receive free reimbursable meals for up to 30-operating days or until a new eligibility determination is made, whichever comes first.**

**Application Reminder:** Eligibility determination requires listing the number of members in a family,  
**Remember to list all household members including elementary children on meal applications.**
