If the student's parent, guardian, or legal custodian is unable, refuses, or is otherwise unavailable to sign their own affidavit, you must also complete item 8.]

The undersigned affiant, being first duly sworn, says that:

  - Abuse or neglect by the parent or legal guardian according to a court of law.
  - The loss of uninhabitability of the student's home as the result of a natural disaster.
4. \_\_\_\_\_ (name of child) is neither suspended nor expelled from a local school unit in this or any other state for conduct that could have led to a suspension or expulsion from the local school administrative unit.
5. I attest that the student's claim of residency is not primarily related to attendance at a particular school within the local administrative unit.

I have been given and accept responsibility for educational decisions for the child, including receiving notices or discipline under North Carolina General Statute 115C-391, attending conferences with school personnel, granting permission for school-related activities, and taking appropriate action in connection with student records.

7. **I acknowledge that willfully and knowingly providing false information in this affidavit is a Class 1 misdemeanor and carries the penalty of paying the local board an amount equal to the cost of education the child during the period of enrollment.**

8. I attest to the fact that the student's parent, guardian, or legal custodian is:
